2. Sub- Junior (U-14),
3. Junior (U-17),
4. Senior National (Above -17),
5. Federation Cup 2025.

Many states showed interest in organising the above championships. After elaborate discussion.

- Tapan Acharya proposed to open for bids and take security deposits.
- Mr Saji proposed that bid amounts should be 25,000 and penalty amount should be 50,000/-...

Below Mentioned states after accepting the above terms agreed to participate.

- A. Mini (U-11) National – Odisha, Assam, Jharkhand – 15<sup>th</sup> to 26<sup>th</sup> September 2025.
- B. Sub- Junior (U-14) National – Uttar Pradesh, Assam, Chhattisgarh – 15<sup>th</sup> to 30<sup>th</sup> November 2025.
- C. Junior (U-17) National – Maharashtra, Tamilnadu, Odisha – 16<sup>th</sup> to 30<sup>th</sup> August 2025.
- D. Senior National (Above -17) – Karnataka – 1<sup>st</sup> to 15<sup>th</sup> November 2025.
- F. Federation Cup 2025 – Jharkhand / Haryana – March 2026.

The President provided guidelines for hosting the championships, emphasizing key requirements:

- The championship venue should be easily accessible, preferably located near a railway station and Airport.
- Proper arrangements for food and hygiene must be ensured, with clean dining facilities.
- Separate toilet facilities must be available for boys and girls.
- The championship venue should be in close proximity to accommodation facilities for participants and Officials.

States willing to host the National Championship are required to submit a deposit of Rs. 25,000. If a state Expresses interest in hosting but later withdraws for any reason, a penalty of Rs. 50,000 will be imposed. However, newly incorporated states will be exempt from the penalty requirements. The decision was finalized

Through voting, and all concerned states must submit their cheques within 25 days.

About Referee, and Coaches Workshops, Mr. Raju Dabhade emphasized the importance of training high-Quality referees for international championships. To achieve this, a 4 to 5-day referee training camp will be Conducted in Pune in May, with the participation of NIS-certified coaches. Simultaneously, a state-level

Championship will be organized to facilitate the theoretical and practical evaluation of referees.

Referees will be graded into categories A, B, and C based on their performance. Additionally, a standardized Dress code for referees across India will be implemented, ensuring uniformity at all championships nationwide, Regardless of location.

This proposal was put forward by Mrs. Archana Kaur and seconded by Mr. Chandeshwar Sahu.

## Agenda 5: International Roll Ball Events

1. The 1st Junior Roll Ball World Cup will be held in Nairobi, Kenya, from 15th April to 22nd April 2025.
2. The 7th Roll Ball World Cup is scheduled to take place in Dubai in December 2025.

Mr. Chetan Bhandwalkar gave information about these Championships.

## Agenda 6: Roll Ball League

2. The President proposed that a referee workshop be organized at the Asian level to enhance the skills and Knowledge of referees across the region.
