NOTIFICATION FOR ELECTION TO THE POSTS OF THE EXECUTIVE BODY OF ROLL BALL FEDERATION OF INDIA FOR THE TERM 2024-28

I have been appointed as the Returning Officer for Roll Ball Federation of India (RBFI) by the President of RBFI to conduct the election for the various posts of the Executive Body of RBFI. Copies of the following documents have been provided to me with the request that the elections be conducted as per the Constitution of the RBFI and Model Election guidelines in the National Sports Development Code, 2011 issued by Ministry of Youth Affairs and Sports, Government of India

1. Notice dated 27.09.2024 issued by the RBFI
2. Constitution of RBFI.
3. Model Election Guidelines.
4. Electoral college in Form-1 duly signed by the Secretary General

2. In order to fill up the various posts of the Executive Body of the RBFI, a Special General Body Meeting (SGM) of RBFI has been called which will be held on 20.10.2024 at 11.00 am onwards at the RBFI Office Pune. **The main agenda for the meeting is to elect candidates for the various posts of the EB of RBFI.**

3. MANNER OF ELECTION:

- The Elections will be held as per the provisions of the Memorandum of Association of RBFI and the guidelines prescribed in the Model Election


Guidelines of National Sports Development Code of India, 2011.

- The election shall be held through secret ballot only. No proxy voting shall be permitted.
- Since every Unit is entitled to nominate not more than two names for the Voter's list, each Unit will have not more than two votes.
- Each voter shall carry document, having his photo, to prove his identity at the time of the election. The document shall have been issued by any authority of the Central or State Government.
- Duly filled-in Nomination forms in Form No: 2 to be physically delivered to the Returning Officer by the candidate himself.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Secunder.
- No person shall be permitted to take back his/her name as proposer/secunder, once the nomination paper subscribed him/her has been delivered to the Returning Officer.
- The employees of Central/State government and their undertakings, if any, will be required to obtain No Objection Certificate (NOC) from their employers and submit the same along with the nomination form, if they wish to contest the elections.

4. The schedule for conduct of the elections of the RBFi along with Form-2 for filing of the nomination and Form-5 for Withdrawal of candidature are attached. Forms have to be submitted in the sealed covers superscribing the details of the post for which nomination is submitted, addressed to the Returning Officer.

5. The relevant forms will be displayed on the website of RBFi and also on the notice board at RO's office at RBFi office Pune.

6. Matters, if any, relating to the election of the RBFi shall be raised before the Returning Officer for Roll Ball Federation of India in writing.
